Why are DBS disclosures required? You will be working with vulnerable children and adults so require an Enhanced DBS check
What documents are required?
3 pieces of relevant ID from the evidence list attached
ID must have your current name and/or address
ID must be original copies (no photocopies or copied from internet i.e. bank statements)
National Insurance number
Provide details and evidence of the month and year you moved into your current property and any previous addresses to cover a minimum of 5 years
Provide details of the month and year of any name changes you have had throughout your life
Once you have your documents you need to make an appointment to take your original documents to be checked by emailing <a href="mailto:dbs@actioniw.org.uk">dbs@actioniw.org.uk</a>

The applicant must try to provide documents from Route 1 first.

#### Route 1

The applicant must be able to show:

- one document from Group 1, below
- 2 further documents from either Group 1, or Group 2a or 2b, below

At least one of the documents must show the applicant's current address.

#### Route 2

If the applicant doesn't have any of the documents in Group 1, then they must be able to show:

- one document from Group 2a
- 2 further documents from either Group 2a or 2b

At least one of the documents must show the applicant's current address. The organisation conducting their ID check must then also use an appropriate external ID validation service to check the application.

#### Route 3

Route 3 can only be used if it's impossible to process the application through Routes 1 or 2.

For Route 3, the applicant must be able to show:

- a birth certificate issued after the time of birth (UK and Channel Islands)
- one document from Group 2a
- 3 further documents from Group 2a or 2b

At least one of the documents must show the applicant's current address. If the applicant can't provide these documents they may need to be fingerprinted.

#### **Group 1: Primary identity documents**

Current Driving Licence – photocard	UK, Isle of Man, Channel Islands and EU (full or provisional)
Birth Certificate – issued at time of birth	UK and Channel Islands – including those issued by UK authorities overseas, eg embassies, High Commissions and HM Forces
Adoption Certificate	UK and Channel Islands

Letter from head teacher or college principal	UK – for 16 to 19 year olds in full time education – only used in exceptional circumstances if other documents cannot be provided	Must still be valid
